Dear Homeowners / Residents of Chardonnay Hills Community:

The Board of Directors has authorized for the recreational facilities to be re-keyed for 2013. This means that the key currently in your possession will no longer work to open the recreational facilities located at 32195 Chemin Clinet and 41067 Promenade Chardonnay Hills, effective April 15, 2013. The new key is being provided to homeowners at no extra charge. If lost or stolen, a replacement key is \$50.00.

IMPORTANT! Your new key will be released in advance of the facilities being re-keyed. Only one (1) key will be issued per unit/residence. You must also be a "member-in-good-standing" in order to receive your new key. Monthly assessments must be current and all outstanding fines paid in full.

You may select from the following: management to contact you when your key is ready to be picked up, or receiving your key via certified mail for a small postage fee. <u>Please be advised keys will not be issued to walkins</u>. In order to obtain your new key, you *must* follow these instructions.

Enclosed you will find four *required* forms and a return envelope.

Release, Hold Harmless and Indemnification Agreement – (two page/front and back) this form is to be filled out by all residents. If the property is leased, it is to be filled out by the 'Tenant(s)' and must be signed and initialed at the bottom of each page. If you are the Owner of Record residing at the property please ensure this form along with the Common Area Key Release form and the Key Release Check-List are completed.

Owner's Assignment of Membership Privileges to Tenant – (single page) for leased properties; this form is to be filled out and signed by the Owner of Record. Must accompany the Release, Hold Harmless and Indemnification Agreement filled out and signed by the Tenant(s), and a copy of the Lease Agreement.

Common Area Key Release Form – this form must be completed by the Owner of Record, specifying instructions for the key release.

Key Release Check-List - Please read carefully and take note of all instructions to obtain your new key.

You may return your forms to Avalon Management by mail, email (<u>Temecula@avalonweb.com</u>), fax (951-699-0522) or drop it off at the Temecula office; 43529 Ridge Park Drive, Temecula, Ca 92590.

Keys are normally issued to the Owner of Record, and it is the Owner's responsibility to give the key to their Tenant(s), unless we receive written/signed instructions otherwise. (See Common Area Key Release Form). Remember, when leasing your property, you are giving up and assigning your rights for use of the facilities to your Tenant(s).

In order to receive a new key, all paperwork must be completed and signed. Incomplete or unsigned forms will be returned, and no key will be issued. For certified mailings you must include a \$6.50 payment; checks made payable to **Avalon Management Group, Inc**.
